# PRESIDENT'S REPORT

This year, the Association became the NSW Table Tennis Association Incorporated, a move which provides greater flexibility and certainly is in the best interest of the development of the sport.

Computerisation of many of the functions the Association previously managed manually has seen great strides towards more efficient operations. By the end of the year a computer will be operational in the Office. Along with the obvious advantages of word processing facilities, the Association will have competent data base facilities and a self-developed software package that provides tournament draws table allocations, etc. In the meantime, the other computer based systems we now have, such as grades and computer rankings, will still be remote from the Office, due to format incompatibility.

Along with the computer ranking system, a Player's Behaviour Code was introduced on a 12 months trial basis. Many people have provided good feedback on both systems and they will be reviewed in light of those comments.

In the Australian Championships in Brisbane, NSW won three of the six teams events - The Senior Mens, as well as the Under 15 Girls and Boys. My congratulations to all players in all teams, as I am well aware that we compete under greater hardships than most of the other States which seem to be able to attract much more financial support than we can gain from either private or Government sources.

Many times this year, I have expressed the concern of the ever increasing competition we face from other more "fashionable" sports which has seen the decrease in numbers of the traditional indoor sports such as Table Tennis. The State Council considered many ways to increase membership, the major idea from many quarters was to reduce State registration fees which they guaranteed would double player numbers. This was an opposite view to those other sports whose fees are much higher than ours yet are increasing in numbers dramatically. After many hours of discussion, this controversial motion was adopted, along with a promotional drive entitled "towards 2000". Many Associations did increase in numbers but the gain was generally only a 5-10% margin above 1986 figures which were the lowest for many years. The unfortunate aspect was the area we were guaranteed to gain significant memberships, the Youth Clubs, produced most disappointing results.

As we move towards 1988, the year in which Table Tennis is to become an Olympic sport, it is ironic that the sport itself in NSW has a problem of identity. It is expected that Table Tennis will gain tremendous coverage from South Korea, yet with this benefit the general public don't even know how to find us. The ball is in each Association's home court to get out there and publicise their competitions, because there will never be a better time.

ANNUAL REPORT

The Fifty-Second Annual Report to be presented to affiliated Associations at the Annual General Meeting to be held at Sports House, 157 Gloucester Street, Sydney, Sunday, 15th November, 1987, commencing 2.00pm.

Ladies and Gentlemen,

During the past twelve months, your Association has undertaken a complex, involved and varied programme of activities.

These have included:

- \* The 1987 Pepsi Cola NSW Closed Championships
- \* The 1987 Commonwealth Bank NSW Open Championships
- \* Entering teams in the Australian Under 21 Championships in Burnie, Tasmania.
- \* Entering teams in the Australian Senior Men and Women Championships.
- \* Entering teams in the Australian Under 17 and Under 15 Girls and Boys Championships.
- \* Entering teams in the Over 40, Over 50, Over 60 Men and Womens Teams National Veterans Championships.
- \* Fielded teams against Victoria in Under 12 and Under 14 Boys and Girls annual event.
- \* Conducting training squads for all of the above teams.
- \* In conjunction with the NSW Umpires, held umpiring functions.
- \* Conducted coaching seminars for all age groups.
- \* Had coaches attend various schools for coaching and demonstration activities.
- \* Supplied back-up staff and facilities for the Oceania Coaching and Umpiring Seminar at which 15 of our members participated lasting for one week.
- \* Took part in the Sun Expo at the State Sports Centre, with an audience of 2000/3000 school children and teachers.
- \* A State Department of Sport coaching week at the State Sports Centre.
- \* Conducted an Elite Junior training week in conjunction with the Metropolitan West Division of the Department of Sport at the E.G. Whitlam Centre, Liverpool.
- \* Held six meetings of the Council of the NSWTTA, various Committee meetings, including meetings of the Executive Committee.
- \* NSW will be represented by one player and two officials at the 1988 Olympic Games.

I will comment briefly on some of these activities and other major events.

Olympic Games. Australian players took part in the Oceania Zone Qualifying Tournament, with G. Haberl and P. Pinkewich selected from NSW and G. Tepper, K. Tepper, N. Bisiach (all Victorians). Three men and two women from New Zealand completed the field.

After three days of some of the best Table Tennis seen in Australia for many years, the following players from Oceania will join the elite band of the

first Table Tennis Olympians ever, a rare honour indeed, and one they will hold for ever.

Once again, outstanding results were obtained, the NSW Mens Team winning the National titles undefeated, including a magnificent 9/0 win over Victoria who, for the first time for several decades, finished in 3rd place. Our Womens Team was once again runners-up to Victoria, after several very close victories against SA and Qld.

The efforts made by our State Team Representatives are deserving the highest praise.

Australian National Under 21 Championships. This was the first time the ATTA conducted this event. It was played in Burnie, Tasmania, and a good entry was received from Victoria, Tasmania, Queensland, South Australia and NSW. There was also a President's team.

M. Bowrey (C), B. Miller and B. Solo represented the State in the Men. No Womens team was sent. The team finished 3rd in the Championships, with M. Bowrey being ranked No. 6 and B. Solo No.9.

This event will be conducted, together with an Under 19 teams event, in Queensland next year and we look forward to full representation, as it should keep many players in the sport.

Olympic Solidarity Course, Narrabeen. This event, funded completely by the Olympic Solidarity Oceania Zone, was conducted over 10 days at the Sports Academy, Narrabeen.

The Course concentrated on tournament administration and coaching of coaches and was a very intense course, with unanimous agreement amongst all course participants that the course was well organised, stimulating and an outstanding success.

Course Lecturers included Mr. Hans Giesecke, Treasurer of the ITTF, Zhou Lansun, Peter Hirst (NZ), Rhonda Scott (NSW).

International Tour. Australia was invited to play in the New Caledonian International in Noumea in July. This tournament was held to mark the opening of a new 8 table stadium, the permanent headquarters of the New Caledonia TTA. Teams of two men players from France, New Zealand, Tahiti, Australia and New Caledonia contested both teams and individual events.

Australia was represented by Cam La (NSW) and G. Tepper (V) and finished in third place in the teams event which was won by France with New Zealand second.

In the Mens Singles event, G. Farout (France) won the final from P. Jackson (NZ). Cam La lost in the  $\frac{1}{4}$ -finals to B. Griffiths (NZ) whilst G. Tepper lost to P. Jackson, also in a  $\frac{1}{4}$ -final.

Congratulations to Cam La on his first National team selection.

Australian Table Tennis Academy. The ATTA opened a 3-table fulltime Academy in the Albert Park Table Tennis Centre, Melbourne, last March. Funded in part by the Australian Institute of Sport, The Australian Sports Commission and the Victorian Department of Sport, players are required to spend at least 20 hours per week on table training and 10 hours weekly in associated training and physical work.

Zhou Lansun, who resided in NSW after his arrival from China, was appointed Academy Coach.

N. Bran joined the Academy on November 2nd and S. Mitchell moves to Melbourne during December and will enter the Academy immediately.

Additional involvement is the main priority under review by the Board of Management of the ATTA and two possible avenues being followed at present include:

- a) A resolution was passed at the last meeting of the Board and we quote - "it was resolved that investigations would be made to decentralise the Academy with the first group being sited in Sydney."
- b) A visiting scholarship scheme to enable players to spend say 3/4 periods of approximately one month at the Academy in Melbourne.

Tour of China. The Academy will send a group of the following players to tour China in December/January. This party will comprise Academy members, G. Tepper, A. Rosario, E. Kasser, R. Moore, B. Peel, J. Perry, R. Tepper, N. Bisiach, J. Tepper, K. Tepper, joined by S. Mitchell(SA) and A. Altuneg(NSW).

Coach will be Zhou Lansun and Manager, J. Bond (Qld.).

Congratulations to Aldwyn Altuneg on her selection.



State Director of Coaching. During the year, Jae Hwa Lee resigned his position as State Coach, after almost five years service. Zhou Lansun, the internationally recognised Chinese coach arrived and resided in Sydney prior to his appointment as Australian TTA Coach at the Academy in Melbourne.

Zhou has since visited all Australian States and says that the technical aspects of NSW juniors play is amongst the highest in Australia, a glowing testimony to the skills of Jae Lee.

Paul Pinkewich was appointed to the vacant position and Paul, after handling mainly State Senior team training, had limited time to devote to NSW U14/U12 players selected to play Victoria in the annual fixture and to the NSW Veterans team contesting the Australian Championships in Hobart early December.

Paul commences working with an Elite State Squad of 20 Senior and Junior players in December and this will run through to the New Year.

It is hoped that all Groups, Clubs, Associations will give Paul Pinkewich their full support. He is one of the State's 'All Time Greats' and in his new and challenging role, deserves the full co-operation of every individual connected with our sport.

City versus Country. An Annual Challenge series between teams representing the Metropolitan and Country Leagues was played in this, its inaugural year, on Sunday, 13th September, at the Beaton Park Leisure Centre and despite a minor hiccup or two, was in the main, a great success.

An unsolicited letter from one of City's players, Derek Kerr, is believed to sum up the feelings of the large majority. Derek says -

"I believe that this type of competition has an enormous potential for the good of Table Tennis in this State, the avenues are endless, i.e., Junior City-Country, Senior City-Country, Veterans City-Country. It would be an excellent vehicle for the selection of State teams and would ensure the organisers would receive a good entry."

This fixture will again be played at Beaton Park, Wollongong, in 1988, with a recommendation to go before the incoming Executive that participation in this event be a qualifying requirement for State team selection.

For the record, Country won the Friendship Cup, donated by Keith Bowler, with a scoreline of 24-5 and have thrown down the gauntlet to City players and officials alike for a more spirited clash in 1988.

Olympic Games Fund-Raising. Whilst NSW Olympians are treated very well financially, the NSW Division of the AOF can only assist its representatives with the aid of fund-raising with all sports involved.

This means the NSWTTA has to support Olympic Games fund-raising activities which commence this year.

Bi-Centennary. The 1988 Australian National Senior Championships, allocated to the NSWTTA by the Australian Association, have been officially given Bi-Centennary endorsement.

The Liverpool Council's Community Bi-Centennary Committee are a joint sponsor of the National Championships besides being a co-organiser of this event

which is listed amongst the 200 major Bi-Centenary events to be conducted in NSW during 1988.

Patron. It is with pride we announce the acceptance of Patron of the 1988 Australian Bi-Centenary Championships by the Hon.E.G. Whitlam,AC, QC.

Mr. Whitlam's exact involvement will be known when his Paris commitments to the Executive Board of UNESCO are known.

It is planned to invite China Sweden, Korea, USA, New Zealand and Australia to compete in the International event.

If these plans come to fruition, this will be the first time in over 50 years that all Australian State teams and International teams will gather at the one venue, in what would be Australia's biggest ever week of Table Tennis.

## TREASURER

Ladies & Gentlemen

I present the Financial Report & Balance Sheet for the year 1st October 1986 to 30th September 1987.

Unfortunately I have to report that the Association incurred a loss of \$3744-92 for the year. I can attribute part of this to monies that have been paid out for the 1987 Australian Championships but have not yet been recovered from the players and officials that went to Brisbane. This would account for approximately \$3000-00 of the loss with the remainder being put down to the decrease in our fees plus a small increase in our operating costs.

Our total administration costs increased by only 10%, however our insurance costs increased by 64%, mainly due to an increase in Workers Compensation and taking out of a Public Liability and Contents policies.

All tournaments conducted by NSWTTA Inc made a small profit. At least we didn't loose money on these events.

This year the Executive Director commenced marketing Table Tennis equipment through the office. It was not expected to be a big money raiser but mainly done to generate turnover through the books and allow the Executive Director another avenue to promote the game.

Income from our traditional sources, such as registrations, and the development levy is down from last year. Obviously the decision to introduce a fee scale was the main factor in part of the loss. We hoped that the decrease in fees might lead to an increase in players, but unfortunately this did not eventuate. We in fact did have an increase in players, but not significant enough to offset any loss.

Overall it is a poor result for a year that we expected much more from than we got.

Next year with the Bi-Centennial Australian Championships and a few other new concepts being considered, I feel that we will have to watch our funds very carefully. Although warranted I cannot recommend an increase in the current fees for next year except for the Association Affiliation fee, of which a new concept is proposed to deal with affiliation to the NSWTTA Inc, and to one of it's Co-ordinating Leagues.

I urge that all associations, players and officials get behind the Association for 1988 and support it to their utmost.

I look forward to a better 1988.

## EXPLANATORY NOTES

- (NOTE 1) Because of our Financial Year ending on the 30th September each year, which in effect splits the year, some projects for which we have received income or expended monies on were commenced in the previous financial year and completed in this financial year. Therefore to obtain a clear picture of an actual event you will need to total the figures from 1986 and 1987 to obtain the correct result.
- (NOTE 2) Similarly in this case we have already expended monies for the 1987 championships, but have yet to recover some of the costs from players and officials who represented NSW in state teams.
- (NOTE 3) The net amount under this heading is being held on behalf of the Veterans Committee who have been actively fund raising to assist their team members go to the Veterans Championships in Hobart. This money will be fully utilised by the Veterans in November.
- (NOTE 4) These amounts are large due to the fact that Grant Monies received of \$26500-00 were incorrectly credited to the General Account instead of the Grant Account.
- (NOTE 5) All Government Grants are for the financial period 1st January 1987 to 31st December 1987, therefore all unexpended Grant monies should be expended by the end of the year. However as we know that some monies will not be able to be utilised until 1988, the government has been advised, and has agreed to us holding the funds until satisfactorily expended.  
Any money not utilised for the purpose for which it was granted is required to be returned to the Department of Sport & Recreation.
