PRESIDENT'S REPORT

1984 has marked the commencement of a new era for New South Wales Table Tennis.

A new organisational structure of the Association, giving both the Country and Metropolitan Leagues full representation on Council, has worked extremely well, with excellent attendances at Council meetings.

Also, the introduction of the individual players registration fee has been most successful, with an increase in the number of affiliated associations from 15 to 24.

Due to losses brought forward from previous years, we started 1984 in a poor financial position. However, due to the efforts of our new Treasurer, Phil Males, and sounder financial management by Council, we have now greatly stabilised the Association's finances.

Looking forward to 1985, we are excited by the facilities to be provided at the new State Sports Centre, Homebush Bay. Due to open in November, 1984, this will provide a top-class venue for State Championships and training sessions.

Our players again played well in National Championships, although we only brought home one title and that by Lisa Schvartsberg in the Under 15 Girls Singles.

It was good to see an increase in the entries at open tournaments, especially in the grade events. The highlight of the tournament calendar was the State Open Championships which featured the Japanese National Team.

On the disappointing side, it was necessary to give up the lease on the Showground Hall, due to lack of support from players, and this also caused the cancellation of a number of fund-raising events during the year.

The State Association is an elected body - elected by all who play throughout the State. The results of the Association are directly related to the efforts of all who play - without this support, the game will not develop its potential.

NEW SOUTH WALES TABLE TENNIS ASSOCIATION

ANNUAL REPORT

The Forty-ninth Annual Report to be presented to Affiliated Associations at the Annual General Meeting to be held at Sports House, 157 Gloucester Street, Sydney, on Sunday, 11th November, 1984, commencing 2.00pm.

Ladies and Gentlemen,

During the past twelve months, one of the main areas of development was a complete updating of the Association's Constitution which was first adopted some 50 years back, naturally with many amendments. However, this was the first major review and changes were made at a two-meeting conference, the first a working meeting on changes proposed, then a draft Constitution agreed to and finally approved at a Special General Meeting.

The main change was in the facet of controlling the Association's activities during the year, in the formation of the Council of Management. Previously, a sixteen person committee mainly comprised of Metropolitan officials, with meetings held in Sydney monthly, the Council now comprises elected President, Hon. Secretary and Hon. Treasurer, with eight Association representatives, four from both the Country and Metropolitan areas.

Council meetings are held every two months, alternatively in the City and Country. To date, Country meetings have been held in Gosford, Goulburn and Wollongong.

This type of management has provided the State Association with a full Committee for the first time for some 8 years. Indeed, both the Country and Metropolitan Leagues have officials on 'stand-by' awaiting nomination.

The theory of greater representation and involvement at the top level of management by Country officials is well and probably overdue, as our Country associations provide 50% of the registered players in the entire State.

Allied to this change was the introduction of the individual players registration scheme. This meant that NSW was able to reduce the association affiliation fee to a nominal amount and as a result, affiliated associations have increased from 15 to 24, the increase being in small associations - 4 from the Country and 5 in the Metropolitan area.

The individual players registration scheme has increased some 30-50% the time taken by the State Body in this area. Naturally, in any initial year of a new operation, there are teething problems and by improved registration methods next year, this time will be decreased. However, it is still a large dent in the administration hours spent at our Office.

It is pleasing to note the increased number of associations. However, at the time of writing the actual number of registered players is lower than the estimated numbers we had last year. We are looking into this but naturally enough, some initial reaction against an individual fee was to be expected.

We continued our excellent relationship with the NSW State Government and owe a lot of our financial stability to generous Grants received from the Department of Leisure, Sport & Tourism. A change of policy agreed to by the Executive saw the main thrust of our application to part-time staff in three sections, Executive Director, Director of Coaching and an Assistant Administrator, instead

of one full-time and one part-time Grant last year. It is felt that this move has greatly improved the output of assistance to affiliated bodies and individual players.

All who have followed the progress of the State Indoor Sports Centre at Homebush Bay look forward to its opening late in 1984. This venue will be of world class and we hope, will play a major part in our activities in the future.

The financial position of the State Association, for the first time in some years, is on the improve and careful management, planning for reserve funds for future development and the prudent use of limited funds at our disposal, will result in a vastly improved position at the end of our financial year.

During the past twelve months, seminars on subjects ranging from coaching to administration aspects of running the sport, have been conducted and all have been well attended and received. Outside lectures have been used and this facet of the sport will be increased in the coming twelve months.

Plans are in hand to use Department of Sport facilities at the National Fitness Centre at Narabeen and the Homebush Bay venue when available.

On the playing side, ten open championships were held during the year, with several 'Top Ten' tournaments. Coaching was concentrated in the junior area for the period until the National Junior Championships, then reverted to the senior players for several months, with the Under 14/12 groups also catered for, leading up to their interstate series against Victoria in Wagga Wagga later this year.

Of special interest is the increasing involvement of "Veterans" events, with the first Australian Veterans Championships scheduled for Hobart this year.

1984 NATIONAL OPEN CHAMPIONSHIPS

Teams represented NSW in both Men and Women events in the 1984 National Championships which were played in Melbourne. They were:

The Mens team once again finished in second position to Victoria, who fielded a powerful team comprising two former Swedish players, one ex-Polish player as well as two Australian Internationals. Therefore, our second placing with an all home grown 'made in Australia' team was quite a good effort.

Our Womens team also finished in second place, losing to Victoria in the final, scoring a heart-stopping 5/4 win from Queensland and defeating all other States.

National rankings obtained by NSW players were:

G. Haberl (3), Pinkewich (5), W. Heginbotham (E10), A. Campbell (E7) and M. Sterland (9).

NSW STATE OPEN CHAMPIONSHIPS

These championships were held at the Alexandria Basketball Stadium and were an unqualified success.

We were most fortunate to be able to arrange a visit by a Japanese touring team to coincide with the playing of the State titles and the presence of World ranked stars, H. Abe, M. Maehara and Japan International, I. Hoshino, added a great deal of interest to the State Open. Several interstate juniors also competed

in junior events. These entries raised the standard of play and enthralled both players and spectators alike with the table tennis during the events.

Time-wise, the events generally were running behind schedule, more so in the events on the Saturday, rather than the open events. But it is interesting to note that in excess of 240 matches were played on Saturday and if every player was only one minute late arriving at the table for their scheduled game, we would have lost 4 hours, and this we did.

The 1984 NSW Open was a direct contrast to the State Championships of 1983 which were most disappointing. This year, we had good entries, good play, good crowds and most importantly, good table tennis in all sections.

NSW CLOSED CHAMPIONSHIPS

One of the most successful Closed Championships ever held, with an excellent venue, large entries, terrific atmosphere and good "Finals" programme.

This Championships was honoured by the presence of Mr. Paul Landa, the NSW Attorney-General.

AUSTRALIAN JUNIOR CHAMPIONSHIPS

NSW entered teams in all sections in the 1984 National Junior titles held in Perth.

L. Schvartsberg won the only title for NSW, winning the Under 15 Girls Singles. The Under 17 Boys team finished 4th, the girls finishing 2nd. In the Under 15 section, the boys finished 2nd and the Girls 4th.

COACHING REPORT 1984

In New South Wales over the past twelve months, interest in the coaching sphere has grown appreciably. This growth is partly due to new-found enthusiasm by previously involved coaches and the emergence of a new breed of active coaches and coaching administrators.

The cohesion with which these groups have been able to operate has led to a greater appreciation of the importance of all areas of coaching in the development of table tennis; both at the grassroots or base level and also in respect to elite performers.

It is hoped that this renewed interest will continue so that new plans and projects already formulated can come to fruition in future years.

During 1983/84, the following projects were undertaken:

1. Coaching of coaches seminars
 - a) Meet the coaches
 - b) Level 1 coaching of coaches courses
 - c) Post Level 1 Camp to be held at the Narrabeen Fitness Centre.

2. Coaching of senior squads and teams
3. Coaching of junior squads and teams, Under 15 and 17, Under 12 and 14
4. Coaching in schools and youth organisations such as Police Citizens Boys Clubs Federation
5. Non-Elite coaching in Country areas
6. Women's Grade training squads
7. Coaching at Disabled Associations

It is envisaged that by the end of 1984, a further 10-15 coaches will have attained Level 1 status, indicating a healthy future in the growth of coaching standards overall.

INTERNATIONAL NEWS

During the year, the ITTF expanded on the 1983 Rubber Rule with a clearer definition of colours that can or cannot be used on the two sides of a blade.

The visit of a touring Japanese team who played in the State Open Championships has already been mentioned. The players, A.Abe, M.Maehara and I. Hoshino also played in a six player tournament at Sutherland and again, Abe won the final from Maehara.

We were also pleased to host a team of veteran lady players from the Republic of Korea. They played a social match at the Seaforth Community Centre and entered various events in the Northern Suburbs Championships.

Olympic Games

Table Tennis is a fully competitive sport to be played for the first time at the 1985 Olympiad in Seoul, Korea.

The details of Country and/or Continental representation will be finalised at the ITTF meeting to be held in Gothenburg, Sweden, during April 1985.

At the present time, the Oceania Zone has been allocated 2 male and 1 female representative. This is to be confirmed and if it is the case, a battle royal will be on between leading Australian and New Zealand players to gain Olympic Games selection.

We are writing into our Constitution, ITTF Regulations relating to Olympic Games Eligibility and these Rules are of major importance, to be studied

by both leading players and juniors alike.

Some groups in the past have used certain fund-raising activities which are now well outside Olympic eligibility guidelines. No doubt, these functions have raised hundreds of dollars but ALL Table Tennis Officials must be extremely careful not to upset the possible eligibility of any potential Olympian, as the benefits to such players are unlimited.

You are urged to check with the NSWTTA on this matter.

PUBLICITY

Once again, we were not successful in obtaining a Publicity Officer and the Executive Director, associated with Mr. A. Wong, combined to achieve a reasonable amount of newspaper space. Several ½ page articles appeared in the Sunday Press, the "Daily Mirror" featured table tennis on many occasions and results of local, national and international championships appeared in the sporting results columns of the "Sydney Morning Herald" and the "Daily Telegraph".

The Australian Championships were televised on Channel 2 - a one hour Saturday afternoon programme. Highlights of the Australia v Japan international match played in Melbourne was on several sporting programmes on Channel 0/28.

In addition, an Open Tournament was held at Lismore by the Far North Coast Association which attracted a large entry from Queensland as well as New South Wales players.

UNDER 14/12 MATCHES v VICTORIA

This series is now well established with the 3rd Annual Fixture played against Victoria in Wagga Wagga on October 26th/27th at the Police Boys Club.

Two teams are selected in each age group Under 14 Girls and Boys and Under 12 Girls and Boys.

UMPIRES

The New South Wales Umpires continued to work diligently during the year, providing Tournament Referees for all Open tournaments and assisting the Association in running the Championships. Their umpiring at the NSW Open and Closed Championships and the international tournament at Sutherland was, as usual, up to their high standards. We now have 4 International Umpires and one National Umpire in this State.

Stuart Scott was appointed to the Oceania panel of Umpires to participate in the Commonwealth and World Championships in 1985.

AUSTRALIAN TABLE TENNIS ASSOCIATION

At the ATTA General Personal Meeting held recently in Melbourne, our Delegate, Keith Bowler, was elected Vice-President of the ATTA and our Hon. Treasurer, Phil Males, was elected Hon. Treasurer of the Australian Association. We congratulate both gentlemen on their appointment to these positions.

Open ranked players below 10 (Men) and 8 (Women) are eligible to play in A Grade.

All other players, other than those listed in C Grade above, are considered to be D Grade.

One win in D Grade means promotion to C Grade. 1 win in C Grade promoted to B. Grade and at least two wins in B Grade promoted to A Grade.

Treasurers Report

=====

I have pleasure in presenting the Financial Report and Balance Sheet for the 11 months from 1 November 1983 to 30 September 1984.

As the books had to be closed at the end of September the majority of income & expenditure for the 1984 Australian Open Championships and the 1984 Veterans Championships in Hobart will not reflect in this report.

In the past 11 months the Association has managed to stay in front and we have in fact managed to establish a reserve fund of which 5% of all our General income is deposited as well as proceeds from the sale of our fixed assets, namely tables, nets and barriers. This reserve fund will only be broached in an extreme emergency and if we can build it up to a reasonable figure, in due course the benefits will be for you, the players.

The introduction of the player registration scheme saw NSW charge a fee of \$5-00 of which \$2-00 would go to the ATTA. As at 30 Sept. 1984 we have 871 registered members which has brought in a net figure of \$2613-00 to the Association. This is a fairly small amount to provide a working base and unless more players/officials can be registered the fee may have to be increased for 1985.

It is distressing to note the length of time that people take to pay their accounts. Quite often there are outstanding accounts over three months. How we are suppose to pay the bills if you don't pay us what is owed. In some cases this year mail has gone astray and by the time a follow up account is prepared, sent and payment finally received, that does take some time which is unfortunate and not the fault of the debtor. Of the Sundry Debtors mentioned in the report, payment has been received from Mr Hawkins and Mr Lee since closing the books. I would ask that when anybody is billed that they please pay the account promptly.

We still are to receive from the ATTA a grant of \$1200-00 which was made by the Japanese Foundation of Australia in sponsorship for the Japanese Tour in August. This will reimburse us for the expenditure on the NSW Open and costs of the Japanese players and officials whilst in New South Wales. As ATTA Treasurer I hope to be able to make that payment soon.

A pleasing report I have to make is that we have received confirmation from the Royal Agricultural Society that we do not owe any further monies to them for the Showground Complex that the Association rented in 1983. At the beginning of the year we estimated a further outlay of approximately \$1700-00, however after numerous approaches by correspondence, we eventually received a reply confirming that no further amounts were owing.

The investment of our unexpended grant monies and interest on the accounts has yielded nearly \$2000-00 in interest during the year. This has remained untouched to date, however it will be taken into General funds soon to be used for the benefit and promotion of the game of Table Tennis.

You will note that a comparison between 1983 & 1984 figures has not been done in this report. This is due to the fact that since the restructure of the NSWTTA, 1985 will be the first year that we will have a full 12 month period to report on.

I have enjoyed being Treasurer of the NSWTTA and if elected, I look forward to doing the job again next year.
