

ANNUAL REPORT.

NINTH ANNUAL REPORT AND BALANCE SHEET to be presented to Members at the Annual General Meeting to be held at Railway Institute Hall, Devonshire Street, Sydney, on Monday, 27th February, 1939, at 7 p.m. sharp.

LADIES AND GENTLEMEN,

The Ninth Annual Report and Balance Sheet of the New South Wales Table Tennis Association are presented herewith.

In presenting this report we record a year of success and further progress for the game in this State.

During the year, which has been one of the most outstanding in the history of the Association, more general interest than ever before was created in Table Tennis mainly because of the visits to New South Wales by the overseas World Champions, Viktor Barna and Lazlo Bellak, whose exhibitions of fast and spectacular play provided such wonderful entertainment. This visit of the world famous Barna and Bellak followed closely the visit by two other World Champions, Miklos Szabados and Istvan Kelen in 1937. Thus, within two years the New South Wales Association, in co-operation with the Australian Table Tennis Association, has been able to provide members of the Association with exhibitions by the world's best table tennis players. Such exhibitions will be of untold wealth to those members who can profit by the demonstrations given both in the singles and the doubles game.

All members of the Council have worked harmoniously throughout the year and the same high standard of efficiency as shown in previous years in running the affairs of the Association has been maintained.

All officers elected at the last Annual Meeting have completed a full year of office and so far as records show, this is the first year which has been completed without any changes in the personnel.

During the year 24 meetings of Council were held.

TEAMS PREMIERSHIP COMPETITIONS: Ninety-one teams, being the same number as in the year 1937-38 commenced play on the 6th April, 1938, and a No. 2 Competition commenced on the 22nd June, 1938, with ten teams. The total number of teams in both competitions for the season was 101, being 2 more than the season 1936-37 but still one less than the record entry of 102 in 1935-36.

Teams generally displayed great keenness throughout the competition. This was particularly noticeable in the "A" Grade right throughout the competition; no one team assumed a winning position, the final being in doubt up to the last set. Insurance 1 were the winners by a narrow margin of 1 game only.

Annual Match: N.S.W. Assn. versus Insurance Assn. This interassociation match was played at the Y.M.C.A. Hall, Sydney, on Tuesday, 2nd August, 1938, and resulted in a victory for the N.S.W. Association by 10 sets 85 games to 8 sets 71 games.

The N.S.W. Association side comprised: A. Bowe, M. Greene, J. Martin, V. Veinberg, H. Allen and G. Crowle, while the Insurance Association was represented by K. Baker, C. Comber, W. Symonds and M. Coates.

Prior to this match each Association shared an equal number of wins. In view of the N.S.W. Association now having one win to its credit more than the Insurance Association, it can be expected that the Insurance team this year will be "flat out" in an endeavour to even the matches up.

The fixture is one of the most interesting of the regular matches each year, and it is most disappointing that a greater number of the members of the Association do not display sufficient interest and give the event the support that it deserves. The State's most brilliant players are chosen for the respective sides and much time is devoted by the teams in practising prior to the match, whilst the Executives of each Association share in organising for the event. A hall is rented each year in order to provide good conditions for members and public to view the match and the nett profits (if any) are divided between the Associations concerned.

It is regretted to report that due to the lack of support this fixture has resulted in a financial loss for the past two years.

It is hoped, however, that members will rally more to the support of this important fixture in future.

State Championships: Although the number of entries for the State Championships this year was not as heavy as the Carnival year of 1937 it is considered that the entries received, viz. 338, to be very satisfactory when compared with the previous record year (prior to the Carnival year) when the entries totalled 336.

The final night was staged at the Australian Hall on Wednesday, 29th June, 1938, under the most ideal conditions never before provided for Table Tennis in Australia. Much time and considerable expense was put into the providing of special high power non-glare lights for the players and tiered seating for the spectators. Our thanks in this connection are mainly due to Mr. W. E. Robbins, who devoted considerable time to the carrying out of experiments and designing of the lights, which resulted in players being provided with ideal playing conditions.

City of Sydney Championships: The Railway Institute Association was again granted permission to conduct the City of Sydney Championships.

These events were held at the Railway Institute under well organised conditions, the Open Singles being won by the State Titleholder, A. Bowe.

Annual Ball: The Third Annual Ball was held at the Paddington Town Hall on Friday, 7th October, 1938, when the President, Mr. H. G. Schachtel presented trophies won at the State Championships and 1938 Teams Competition.

This function, although not fulfilling expectations with regard to attendance, was an outstanding social success.

Wonderful camaraderie existed among the various parties present.

The Insurance Officers Association conducted a teams competition, as usual, during the year. "Liverpool, London & Globe" won the "A" Grade for the second year in succession and the third time since the commencement of the Association.

The team was ably captained by M. Coates and was given a great amount of support by their local manager, Mr. Dunlop.

Ken McAuley, 16 year old left-handed junior, made a name for himself in Insurance Officers Association by winning that Associations "B" Grade Championship. McAuley has been playing table tennis only 14 months. In these Championships C. Comber lost to K. Baker in the Insurance Open Singles Event. After winning the first set 6-0 and leading 2-0 in the second set he was finally defeated by K. Baker after a most thrilling match, the score being 0-6, 6-2, 6-4. Keith Baker has now won this title 4 times out of 5.

Congratulations go out to Mr. W. Harper, Secretary of the Railway Institute Table Tennis Association. It is pleasing to note that this Association's efforts during the year were crowned with success. Two major carnivals, the City of Sydney Championships and the Interstate Railways Teams and Individual Championships, were conducted during the year and the Committee in general and Mr. Harper in particular are congratulated upon the manner in which these functions were organised. The City of Sydney Championships attracted just on 400 entries.

Publicity: Publicity during the year was very satisfactory, and it is fitting that it should be here recorded the appreciation of the Association for the efforts of Mr. Geoff Allen in this regard, especially in regard to his articles which have appeared in the "Sun" regularly throughout the year.

Our thanks are also tendered to the sporting editors of all daily newspapers and broadcasting stations for the publicity given, as it was due in no small measure to the publicity given through these mediums that the Barna-Bellak Exhibitions drew such large crowds Trophies Donated: The President, Mr. H. G. Schachtel, donated a handsome trophy for the Ladies Singles Championships of N.S.W., and Mrs. C. Jarvis donated the Cup for the Open Singles Championship of N.S.W.

The Association desires to thank the donors for their generosity and the very practical interest displayed.

Prior to arrival in Australia exhibitions were given in New Zealand, where an extensive tour of both the North and South Isles had been arranged by the New Zealand Association.

While in Australia, Viktor Barna and Lazlo Bellak visited and gave exhibitions in New South Wales, Victoria, South Australia, Queensland and Tasmania, and drew large and appreciative audiences on every occasion.

While in Sydney five public exhibitions were given, four nights at the Australian Hall and one at Rockdale, in addition to which a private exhibition was given at City Tattersall's Club for the benefit of press and radio representatives, and a further private exhibition was given to the staff of the Elliott & Australian Drug Co. Ltd., the latter being arranged at the request of Mr. H. N. Smith. Players have benefited greatly by their matches with the Hungarians and have been practising assiduously in an effort to emulate the style of play favoured by Barna and Bellak.

Messrs. Barna and Bellak made many friends by their genial personality and displayed a marked degree of willingness at all times to show their best where and whenever games were arranged for them. On every occasion that they appeared they played "flat out" from the first service. Their all round exposition and sporting disposition won the admiration of audiences at every public appearance.

We take this opportunity of placing on record our sincere thanks to them for making the tour and to Mr. H. N. Smith for making the tour possible.

Australian Table Tennis Association: A great deal of work was carried out during the year by the Delegates from each of the State Associations, both in regard to matters affecting Table Tennis from an Australian viewpoint, and in regard to the visit by Barna and Bellak from overseas.

As is well known, the laws of Table Tennis have not been uniform throughout Australia. One of the objects of the Australian body is to have uniform laws adopted by each State, and with this object in view the Australian Association during the year adopted the Laws of Table Tennis as used in International Competitions. South Australia, Victoria, Queensland and Tasmania adopted the uniform laws, this step being a most important one indeed in the administration of the game throughout Australia.

The New South Wales Council, taking all factors into consideration, has decided to support the move for the adoption of the uniform laws and has brought the matter before members for decision at the Annual Meeting.

The Council recommends the adoption by New South Wales of the Laws of Table Tennis as adopted for international competitions. New South Wales is the only State in Australia playing under different laws, and no matter what one's opinion is as to the merits or otherwise of the subject, the Council is of the opinion that New South Wales must fall in line with the rest of Australia.

Therefore, with the object of attaining uniformity with the rest of Australia and the world, your Council strongly recommends all members to bring about the adoption of the new laws.

The visit of Barna and Bellak during the year was arranged through the Australian Association and the confusion and duplication of work which was evident during the visit of Szabados and Kelen in 1937 (at which time the Australian Association was not properly constituted) were entirely absent. The amount of detail work in connection with the visit of the overseas visitors was tremendous, and the appreciation by New South Wales of the untiring and efficient handling of matters by the Australian Association Honorary Secretary, Mr. Ron Jones, of the Victorian T.T. Association, is acknowledged.

Tasmania affiliated to the Australian Association during the year—thus now Queensland, New South Wales, Victoria, Tasmania and South Australia form the Australian body, in which the control of the game in Australia is vested.

Memorial to late Cecil J. Smith: A very striking and fitting memorial trophy has been provided to perpetuate the memory of the late Cecil J. Smith, who passed away on the 26th September, 1937.



Those who knew this very fine young man and those players who associated with him in Table Tennis will always remember his splendid personality, cheerful demeanour and complete unselfishness at all times and in all circumstances, which won for him the admiration and esteem of all.

In 1935 he won the Open Singles Championship of New South Wales. This was his first year in competitive table tennis, at which time he was playing "C" Grade in the teams' competition with Macdonald Hamilton club.

In 1936 he was runner-up to Keith Baker in the Open Singles and also in the Open Doubles event. The following year (1937) he won his second State Open Singles Title and his first Open Doubles Title—his partner in the doubles being Charlie Comber. A little later he won the Open Singles and Doubles Titles in the City of Sydney Championships. The same year he represented New South Wales in the three Interstate fixtures in the Third Australian Carnival, and qualified for the semi-final of the Australian Singles event, going down to the Hungarian player, Istvan Kelen.

Cecil also held a wonderful record in Lawn Tennis and at cricket he was an excellent all round player. His achievements in competitive sport falls to the lot of very few so young as he was.

The Cecil J. Smith Memorial Trophy is to be played for in the State Open Singles event each year and will be held by the winner of the title, being passed on from time to time as the title is won.

The name of Arthur, Bowe, being the first player to win the title after Cecil's death, will be the first to appear on the trophy.

Arthur Bowe will receive the trophy at the Annual General Meeting and will hold same for the period that he retains the State Open Singles title.

An opportunity was afforded all clubs to contribute to the cost of purchasing this trophy. The following contributions have been received up to the time this report goes to print, and are gratefully acknowledged herein:—
