## **PRESIDENT'S REPORT**

### **Restructuring**

The Council and Executive of New South Wales since December have come together to work out a strategy to restructure Table Tennis in NSW to bring us up-to-date with sports administration and set the frame work to run on business-like principles. The starting point was to accept the criticism that we hadn't achieved much success in either increasing the number of players or lifting the profile of the sport in this State. A review of the manner in which we conducted our business highlighted faults, though unintentional, and by well-meaning people, meant that things just didn't happen. Where did we start.

1. Our Constitution upon examination was outdated. It had been framed around delegates of Associations coming together, with the Executives able to make decisions between meetings providing they were ratified at the next Council meeting. The concept of having delegates meant people "represented" their Association, not necessarily providing any more input to the operations than to express a point of view at Council meetings. The answer was to change the Constitution so that a Board of Management could run the business, meeting more frequently, with policy formulated from "Directors" each having a portfolio with outlined responsibilities. The new Constitution was adopted on June 4 with the following structure:

The Administration Director is a position on the Board filled by one of the Board Members.

2. The old Constitution did not recognise players as members, only Associations. This was a hindrance to people registering. The new Constitution now recognises players as members and Clubs and Associations as Affiliates.
3. In line with the Australian body, we changed our name to Table Tennis New South Wales.
4. Our previous business plan, though sound in principle, was like an impost from above. Allegiance and ownership of the plan rested with a few. Our new plan has been framed around the Directorships, with input from Council to put together a 4-Year Business Plan with a one-year operational plan. This plan has been submitted to Government as part of our application for Grants for the 1994/5 financial year.

PRESIDENT'S REPORT            cont'd

5. The 4-Year Business Plan has specific objectives and key performance indicators that all, including the Government funded positions, will be measured against. The main objectives are:

A 20% increase in membership per year  
Permanent playing centre leading up to the  
Olympic Games.  
Decentralised training centres

6. Future Council meetings will revolve around achievements against the business plan, rather than administrative matters.

**Championships**

NSW played host to the Australian Veterans Championships in October 1993. The venue for this Championships being the BHP Sports Centre at Unanderra, a suburb of Wollongong, approximately 100 kilometres south of Sydney. There was concern that these Championships could be poorly supported due to its location and the closeness to the World Veterans Championships in Melbourne in the following April. The Championships, however, were a success, with over 200 competitors from all over Australian and New Zealand. Media coverage of the event was excellent, with the print and television coverage and interviews reaching a large audience in Southern NSW. NSW also bid for the 1994 Junior Championships, however we weren't this time successful. The National Schools Championships were also held at Unanderra.

## EXECUTIVE DIRECTOR'S REPORT

When submitting this report, it is obvious that this will be the last time I will be responsible for compiling a NSW Table Tennis Association's Annual Report, as in a few weeks/months time, my successor will be named and installed as Executive Director.

The year under review is one with change in the air, as NSW moves from a Council solely, to a Board-type structure and Council portfolio holders.

Our Constitution has been rewritten to cover such changes and a series of meetings have been held to approve such changes, which include a change of membership from affiliated Associations only to registered members, thus reversing the exact opposite change that occurred in the early 1980s.

We will also have a name change from the NEW SOUTH WALES TABLE TENNIS ASSOCIATION to TABLE TENNIS NSW INC.

These tasks alone have created a mountain of work for some senior officials and my congratulations are extended to them.

The staging of the 1993 Australian Veterans Championships in Unanderra was the highlight of the year - a record number of teams for an Australian Championship was one of the many records established. The Management of this Championship received much praise from all parts of Australia, again, a huge volume of work for the Management and Tournament Committees, congratulations to those dedicated workers.

Our appreciation of financial and various other methods of support our Association received from the Department of Sport Recreation and Racing, which enables the funding of our office staff, coaching programmes and various development activities to be conducted, is very sincere and very deep.

Noel Shorter resigned as State Director of Coaching during the year and a new appointment will be made as soon as possible. This is one of the main areas that must be targeted for immediate attention, to arrest the declining standards in NSW and return our State to the heady days when we were either the leading State or, at the worst, No. 2.

Another facet of the sport that requires the attention of every NSW Official, at State, affiliated Association and Club level, is the number of registered players, these numbers are far from good and how do we spread the word that people not registering are doing themselves, as well as everyone else interested in the sport, a grave injustice.

Steps already in place have arrested the decline in 1993 as from 1992, and 1994 will see a slight rise but this is far from satisfactory, indeed, NSW still trail South Australia and Queensland.

During the past few months, our Association has received an amount of criticism from Table Tennis Australia, some of it justified, but it has alienated many of our members, a number of hard-working Council members being an example.

It is hoped these days are behind us and we can return to a more harmonious relationship with the National Body. No one minds constructive criticism, however, this is not the way some people have interpreted what has come from the TTA.

Table Tennis needs the dedicated support of all those who undertake voluntary work, especially in a senior position. It makes it most difficult if any such people renig in their duties.

The NSW Association has also given considerable support the formation of a National League team which is enjoying good or, at the worst, reasonable success in its initial season. One area of concern is attendance figures, Sydney is drawing far better than average National League match attendances but still insufficient to make the viability of the Sydney Smashers undoubted in the medium to long term.

The announcement of Sydney's winning bid for the Year 2000 Olympic Games caused great jubilation amongst sporting ranks, as well as throughout all walks of life. With Table Tennis on the Year 2000 Programme, this is of special significance to the NSW Table Tennis Association but just how is still to be worked out. A diagram of the layout at Darling Harbour is attached, any questions contact our Office. S.O.C.O.G. has promised a permanent headquarters for the Table Tennis after the Games are completed. Again the why's and if's and wherefore's are not finalised, apart from the fact that the venue will be at Homebush in the vicinity of the present State Sports Centre.

Our players will benefit, if good enough and possessing the right attitude, Genna Raber must be considered a potential Year 2000 Olympian and Stella Zhou and Ying Kwok must also rate consideration. These players must, if they are to make the grade and if selected, dedicate a good deal of their life to the sport of Table Tennis in the next six years. Also, these players must be assisted by everyone in Table Tennis, as the honours are great.

Looking at our 1994 standards, we must first make a concerted effort to increase the numbers of registered members. We must tackle the problems and reluctance of players in the social area, especially those who play in licensed clubs, Leagues Clubs, RSL's and the like, into becoming more involved in main stream Table Tennis. This year we will have approximately 800 registered members, a dismal record, but just how to attract more than a trickle of unregistered members into our ranks is a problem that has not been solved over the past 10/15/20 years, try as we may. How to obtain a larger percentage of these unaffiliated players? How do attract the lot? No one as yet has been able to arrive a the correct solution, so I trust that the 'new generation officials' can do so, maybe with some constructive assistance from Table Tennis Australia. This matter, together with a vast improvement in playing standards, are the immediate problems for this State. Table Tennis fro the youth, in PCYC and other clubs, in schools in particular, a huge task, that if tackled area by area will be developed.

In conclusion, I would like to thank the many people who have assisted Table Tennis in New South Wales over the past 3-5 decades and their help to me over the years. I leave NSW with a feeling of great achievement, a statement that is certain to raise some eyebrows, but just to keep the sport alive, to keep tournaments and championships going, has been a real problem, let alone improve and achieve all the goals that one would like.

The anti-association feeling has been a battle that has been fought on many fronts, there even has been what I have described as a 5th column element, this group working supposedly for but maintaining an attitude of "we know better", "we can do better", has been a destroying and destabilising factor and it has taken the dedicated efforts of a handful, just to keep the ship afloat and save it from sinking.

Let us now turn to a new generation, work towards the Year 2000 and beyond. Can I hope for full unity, not just a token gesture or nice sounding words, let us ALL aim at making NSW a far better State, taking its proper place in Australian Table Tennis and making an old Table Tennis Official a contented retired official by the Year 2001

Table Tennis in New South Wales has my ever-lasting supporting and dedication in the future, as it has received for the past 45 years.

## TREASURERS REPORT

Ladies & Gentlemen,

I present the Financial Report on the activities of the New South Wales Table Tennis Association Inc for the period 1/4/93 to 31/3/94.

Firstly I would like to clarify that the report shown is not a full report, it is a condensed report. The actual full report is some twenty (20) computer pages. This full report is available for perusal by any member, and questions are invited for clarification on any aspect of the report.

Also, there are some items that appear to be uncompleted and this is the result of activities commenced in the previous financial year and completed in the next financial year, due to our financial year ending on 31st March. With the restructure of the new constitution, this aspect has now been rectified and the financial year of the association will now finish on the 31st December each year. Accordingly there will be an interim period of nine (9) months until the end of 1994. The 31st December date also corresponds with Table Tennis Australia's financial year and will assist in comparing registration figures.

For the year 93/94 the NSWTTA incurred a loss of \$1543.13. This is small considering the volume of money passing through the account, however it is still a loss that should be explained. My interpretation is that some of the events that NSW conduct are badly managed and badly run. I feel that we must address this situation under our new structure. I realise that finding the people to run these events is hard and the few that do contribute their time, do so willingly, but a way must be found to conduct a successful event, that satisfies the players and at the same time is financially viable. We must stop losing money on NSW-conducted championships.

A major loss, as always, is in our administration costs. Unfortunately this is unavoidable. We must have phones, faxes, photocopying etc to operate. In the loss figure are also some salaries paid, insurance costs, lease costs and reimbursement of expenses incurred to executive personnel and the executive director. To offset some of the costs, reimbursement has been obtained from the ATTA, OTTF and CTA for expenses incurred by the executive director in relation to his various other positions held in table tennis circles.

It is unfortunate that NSWTTA will now no longer be able to extend its Public Liability cover to affiliated associations because of the losses incurred in other areas. The cost of providing this cover is astronomical and cannot be justified, especially now under the new constitution where clubs will be allowed to affiliate and members of Table Tennis NSW will be actual persons, not clubs. I believe there has been some criticism of the association for this decision, however to provide this cover as it stands would not be feasible. At the time of renewal of the policy we will review the situation with our insurers to take into account the restructuring of the association.
